Dealer is to return the original TX or RX Connector Cable for credit within 30 days from date of shipment of the Advance Replacement. If the original part is not received by Celerity after 30 days, Celerity will charge the dealer cost value for each part.

Celerity will pre-pay (UPS Ground Service, with tracking) for the parts to be returned to Celerity. We'll reply as soon as possible to discuss the support problem and initiate the Advanced Replacement if necessary and send the Credit Card Authorization to complete.
